## DOG OWNER'S RESPONSIBILITIES

The Dog Act 1976 states dog owners must ensure their dog;

- Wears a collar displaying the owner's name, address and council registration tag when in a public place.
- Is micro-chipped and registered with the Local Council once they reach three months of age. Failure to comply may lead to penalties.
- Is under the control of a competent person on a maximum two-metre lead when in a public place.
- Is exercised off a leash in designated areas only, with the person in control carrying a leash to ensure the dog can be restrained if required.

## Dog registrations must be renewed prior to 1 November

- The Shire must be informed immediately of any change of details (i.e. deceased, ownership, address etc).
- Reduced fees apply upon proof of either current:
  - i) Pensioner Concession Card;
  - ii) State Concession Card; or
  - iii) Commonwealth Seniors Health Card together with Seniors Card.
